

**BOARD OF COMMISSIONERS OF THE COUNTY OF ALLEN
ORDINANCE DATED March 4, 2022
ORDINANCE NUMBER 03-04-22-04**

WHEREAS, the Allen County Department of Health has determined to form a fund for the purpose of accepting funds from the Indiana Department of Health (IDOH) to support the Centers for Disease Control and Prevention's (CDC's) Crisis Co-Ag School Public Health Assistance Program

and

WHEREAS, the Board of Commissioners have determined that establishing an independent fund for that purpose would be the most advantageous to the County and to ensure appropriate tracking of expenditures

NOW, THEREFORE, be it ordained that

Section 1. A new article shall be added to Title 12 to read as follows:

CHAPTER 1

12 – 252 – 1 - 1

CREATION OF THE FUND

There is hereby created a fund to be known as the Crisis Co-Ag School Public Health Assistance Program Fund. Said Fund shall be funded by receipt of funds from the Indiana State of Health (IDOH).

CHAPTER 2

12 -252 - 2 - 1

PURPOSE

The purpose of the Fund shall be to receive and disburse monies for assistance with public health activities in conjunction with schools regarding routine childhood vaccination efforts and infectious disease prevention planning/ activities including staffing, education, travel, promotion and marketing, equipment, furniture, clinic/office supplies, contractual project completion or staffing, as well as all other related operational support efforts for this initiative as determined by the grant contract. Because the funds for this grant are deliverables-based, IDOH has specified that any remaining funds not utilized in achieving the required deliverables may be used for any purpose determined

necessary for the betterment of public health or expansion of capabilities by the local health department including infrastructure and vehicle needs as well as all types listed above or others allowed, following all local finance authority rules for such expenditures.

CHAPTER 3

12 - 252 - 3 - 1

ADMINISTRATION OF FUNDS

This fund shall be administered by the Allen County Department of Health. The funds shall be disbursed by the Allen County Department of Health, without appropriation. No funds from other sources shall be deposited in the Fund.

12 - 252 - 4

CHAPTER 4

12 - 252 - 4 - 1

NON-INVESTMENT AND NON-REVERSION

All amounts placed in the Fund shall not be invested nor accrue interest. Said funds shall not revert to the Health fund at the end of the year.

Section 2. This Ordinance shall become effective as of the date of passage.
