**12-160-1 CHAPTER 1: CREATION OF FUND**

**12-160-1-1**

There is hereby created a Fund to be known as the Allen County Sheriff's Grant fund for the Allen County Sheriff's Department Regional Training Center. Said fund shall be funded by receipt of grants from state agencies, private individuals, businesses and/or foundations. Grant funding and donations shall be made to the County of Allen and/or the Allen County Sheriff's Department for receipt and deposit into the Fund.

**12-160-1-2**

There is hereby created a separate Fund to be known as the Allen County Sheriff's Federal Grant Fund for the Allen County Sheriff's Department Regional Training Center. Said fund shall be funded by receipt of grants from federal agencies. Grant and donations shall be made to the County of Allen and/or the Allen County Sheriff's Department for receipt and deposit into this separate Fund.

**12-160-2 CHAPTER 2: PURPOSE**

**12-160-2-1**

The Purpose of each Fund created by 12-160-1-1 and 12-160-1-2, shall be to receive and disburse monies for the Allen County Sheriff's Department to design, develop, construct and maintain the Allen County Sheriff's Department Regional Training Center in Allen County, Indiana, in compliance with federal and state grant guidelines, foundation guidelines and state law requirements, and only for such approved grant program purposes.

**12-160-3 CHAPTER 3: ADMINISTRATION OF FUNDS**

### **12-160-3-1**

The Allen County Sheriff's Grant Fund for the Allen County Sheriff's Department Regional Training Center created by 12-160-1-1 shall be administered by the Allen County Sheriff's Department. The funds shall be disbursed by the Allen County Sheriff's Department without appropriation. No funds from other sources other than state agency grants, individual donations, business donations or foundation grants shall be deposited in the Fund. In addition, should the Board of Commissioners of Allen County, Indiana and the Allen County Council decide to deposit general fund revenues into the Allen County Sheriff's Grant Fund for the Allen County Sheriff's Department Regional Training Center, such funds shall be deposited in the Fund only with prior approval of the Board of commissioners of Allen County, Indiana, and the Allen County Council.

### **12-160-3-2**

The Allen County Sheriff's Federal Grant Fund for the Allen County Sheriff's Department Regional Training Center shall be administered by the Allen County Sheriff's Department. The funds shall be disbursed by the Allen County Sheriff's Department without appropriation. No funds from other sources other than specific federal agency grants shall be deposited in the Fund.

## **12-160-4 CHAPTER 4: INVESTMENT AND NON- REVERSION**

### **12-160-4-1**

All amounts placed in the Allen County Sheriff's Grant Fund for the Allen County Sheriff's Department Regional Training Center pursuant to 12-160-1-1 shall be invested and reinvested pursuant to the standard procedures followed by Allen County, Indiana, and interest earned shall be credited to the account. Said funds shall not revert to the County's General Fund at the end of the year.

### **12-160-4-2**

All amounts placed in the Allen County Sheriff's Federal Grant Fund for the Allen County Sheriff's Department Regional Training Center pursuant to 12-160-1-2 shall be invested and reinvested pursuant to the standard procedures followed by Allen County, Indiana, and all amounts remaining in the Fund at the end of the year shall not revert but shall remain with said Fund for the purposes set forth above. This Fund shall not receive interest.
