**ARTICLE 178
MULTI-AGENCY COMMUNICATIONS PARTNERSHIP FUND**

12-178-1 Chapter 1: Creation of Fund

12-178-1-1

There is hereby created a Fund to be known as the Multi-Agency Communications Partnership Fund (“MACP Fund”). Said Fund shall be funded by receipt of fees, contributions or grants which have been received or which will be received from individuals, business, not-for-profit organizations, communication service providers, political subdivisions and state agencies for the use and purposes of providing services and communication infrastructure for the Multi-Agency Communications Partnership in Allen County, Indiana, and the City of Fort Wayne. All funds received shall be made payable to the County of Allen for receipt and deposit into the MACP Fund.

12-178-2 Chapter 2: Purpose

12-178-2-1

The Purpose of the MACP Fund created by 12-178-1-1 shall be to receive and disburse monies for the Multi-Agency Communications Partnership in Allen County, Indiana, in accordance with the terms and conditions of the Multi-Agency Communications Partnership Agreement currently in effect wherein the City of Fort Wayne and the County of Allen, Indiana, are parties. The purpose of the Fund is to receive and disburse monies for all operating expenses, infrastructure improvements, and maintenance of the MACP communication system in accordance with the policies and procedures authorized by the Multi-Agency Communications Partnership Agreement and the policies and procedures approved by the Board of the Multi-Agency Communications Partnership from time to time in compliance with state law.

12-178-3 Chapter 3: Administration of Funds

12-178-3-1

The MACP Fund created by 12-178-1-1 shall be maintained by the Allen County Auditor as a designated fund of Allen County government. The funds shall be disbursed by the Allen County Auditor upon authorization and resolution from the MACP Board. All funds currently on deposit at the MACP Credit Union account maintained by the Board of Commissioners of Allen County, Indiana, shall be distributed to the MACP Fund. All future income and funds received from state agencies, private individuals, businesses, communication providers, not-for-profit organization, or other entities of local government shall be paid to the County of Allen and promptly remitted

to the MACP Fund for the uses and purposes thereto. The Allen County Auditor and the Board of Commissioners of Allen County shall provide a monthly accounting report to the MACP Board and the City of Fort Wayne as to all receipts and disbursements and the account balance of the MACP Fund.

12-178-4 Chapter 4: Investment and Non-Reversion

12-178-4-1

All amounts placed in the MACP Fund pursuant to 12-178-1-1 shall be invested and reinvested pursuant to the standard procedures followed by Allen County, Indiana, and interest earned shall be credited to the account. Said funds shall not revert to the Allen County General Fund at the end of the year.
