**ARTICLE 179
COMPREHENSIVE MENTAL HEALTH SERVICES AND
MODIFIED THERAPEUTIC COMMUNITY PROGRAM FUND**

12-179-1 Chapter 1: Creation of Fund

12-179-1-1

There is hereby created a Fund to be known as the COMPREHENSIVE MENTAL HEALTH SERVICES AND MODIFIED THERAPEUTIC COMMUNITY PROGRAM GRANT FUND. Said fund shall be funded by receipt of grants awarded by the Indiana Criminal Justice Institute Board of Trustees. These grant funds shall supplement an existing annual grant allotment from the Indiana Department of Corrections know as the Transitional Housing Component.

12-179-2 Chapter 2: Purpose

12-179-2-1

The Purpose of the Fund shall be to receive and disburse monies for the establishment of a separate facility dedicated to screening offenders by applying an existing Forensic Evaluation process that will also provide comprehensive and integrated treatment interventions to permit a sufficient individualized treatment plan for each Mentally Ill Chemical Abuse offender. Utilization of judicial authority for formatting court ordered case plans and judicial reviews combined with a facility staff development system will enhance probability of success. The residential component will focus on establishing a Modified Therapeutic Community model comprising of residential and aftercare in the form of a day-treatment therapeutic community. This will be accomplished in compliance with federal and state grant guidelines, Allen County and state law requirements, and only for such approved grant program purposes.

12-179-3 Chapter 3: Administration of Funds

12-179-3-1

The Fund shall be administered by Allen County Community Corrections. The funds shall be disbursed by Allen County Community Corrections according to the budget appropriation as approved by the Allen County Council. The Allen County Community Corrections is required to adhere to all administrative and financial requirements established by the Indiana Criminal Justice Institute. No funds from other sources other than as described previously shall be deposited into the Fund. Should the Board of Commissioners of the County of Allen and the Allen County Council decide to deposit general fund revenues into the Allen County Community Corrections COMPREHENSIVE MENTAL HEALTH SERVICES AND MODIFIED

THERAPEUTIC COMMUNITY PROGRAM GRANT FUND, a second fund shall first be created and said funds shall then be deposited into said second fund only with prior approval of the Board of commissioners of Allen County, Indiana, and the Allen County Council.

12-179-4 Chapter 4: Investment and Non-Reversion

12-179-4-1

All amounts placed in the Fund shall be invested and reinvested pursuant to the standard procedures followed by Allen County, Indiana, and all amounts remaining in the Fund at the end of the year shall not revert but shall remain with said Fund for the purposes set forth above. This Fund shall not receive interest.
